- 1- The applicant accepted irrevocably all the conditions of the offer mentioned in the "Acknowledgement Letter" to study in Jalal-Abad State University (JaSU) sent by the representative.
- 2- The representative is to provide the student a study seat in JaSU if the student fulfils all requirements imposed by the administration of JaSU and this form.
- 3- Applicant understands that in order to get his/her visa invitation, he/she should follow the instruction mentioned in the acknowledgment letter.
- 4- The applicant is aware that provided information by the applicants including personal details filled in the Enrolment Form or any other documents or emails or web forms are for the need-to-know basis and for the purposes of accessing and facilitating the applicant admission to Jalal-Abad State University and can be used for this purpose by subcontractors or agents of Jalal-Abad State University or/and the representative.
- 5- Applicant that chose the preparatory courses should also choose the Faculty that he/she wish to continue.
- 6- Applicant failure to get admission to the faculty mentioned in page No.2 and left the Kyrgyzstan with JaSU one way student visa, he/she will get refund of the tuition fee and accommodation charges that was made as advance payment.
- 7- The student is informed that on the second day of his/her arrival to Kyrgyzstan, he/she has to hand over all the necessary documents (which are listed in the university offer letter) to the Administration of International Relations in order to complete his/her admission process to the university.
- 8- The student understands that in case of failure to provide all the necessary documents, the student has to deal with this problem individually with the JaSU administration.
- 9- Student that directed to follow the premedical courses should transfer the payment of the premedical courses according to the acknowledgment letter.
- 10- The representative directs the student to JaSU for realization of training in the faculty mentioned in page No.2.
- 11- The representative will guide the student to complete his/her admission.
- 12- The representative is not to be held responsible for any false document provided by the student.
- 13- Student is offered a place in the hostel in either the two or three-seated rooms depending on the availability upon his/her arrival to JaSU.
- 14- Accommodation charges covered according to the academic year and not on monthly basis.
- 15- If student is expelled or decided to terminate his/her study, he/she will not get any refund.
- 16- If student decided to stay out of the university accommodation, he/she eligible for the accommodation charges refund of the upcoming semester only (if prepaid). This refund only applies if he/she completed all the protocols of moving out of the university accommodation before the upcoming semester started.
- 17- The student is to transfer the annual payments to the representative official accountant for indemnification of training and accommodation charges before the beginning of each academic year and failure to do so he/she will not get the permission slip to attend classes and this will lead to the expulsion from the JaSU.
- 18- In the event where a student is directed by the university to repeat any academic semester or an academic year, the student has to pay the relevant charges to the representative as any other academic year before repeating session starts.
- 19- The representative shall not be held responsible or liable to student that travel with or without permission within any part of Kyrgyzstan or visit other countries including student's homeland during the academic period at the Jalal-Abad State University.
- 20- The representative is to request on behalf of the student a visa invitation from the university if the student fulfils all requirements imposed by the University and this sheet.
- 21- The representative is to inform the university that the student has fulfilled his/her semester or yearly payment as soon as the full payments reach the bank account.
- 22- The student is to take full responsibility to provide the representative a valid travel document and genuine study documents needed for the request of visa invitation from Jalal-Abad State University.
- 23- Study materials are available in the library of JaSU and not always available to borrow out of the library.
- 24- The student is to abide at his/her full responsibility with Kyrgyzstan laws and JaSU rules and regulations.
- 25- The student admits that the responsibility of the representative ends at the moment that the representative sends the visa invitation or informs the University of the Student Payment for each academic year.
- 26- The student admits that if he/she is expelled from Jalal-Abad State University due to academic failure or misbehavior or for any other reason, he/she cannot request from the representative for any refund.
- 27- The student understands that the only way to pay the tuition fee and accommodation fee is to be made through the representative's official bank account or Accountant.
- 28- Refund for any payment is subject to be transfer to the student, parent or sponsor's bank account only by the representative.
- 29- All financial matters such as payments and refunds should be discussed with the representative through the representative email.
- 30- The only payment made directly to the university's bank account is if the student caused any damage or any penalties or any extra classes that he/she requests.
- 31- A limited medical insurance is provided by the representative which is valid for Jalal-Abad city. (Life Insurance not included).
- 32- Upon request the representative is to provide the parents of the student's study achievements.
- 33- Upon admission, the student is to sign the contract with the University.
- 34- Any conflict regarding this terms and conditions should be solved in a friendly manner.
- 35- The student agreed that the representative origin country laws and courts are the only judiciary power that can resolve any disputed matters regarding this terms and conditions in case a friendly solution is not found for any conflict.
- 36- These terms are valid for the whole period of the student studies at JaSU.
- 37- Applicant should arrive in Kyrgyzstan with the visa validity period of not less than ONE MONTH. Failure to do so the applicant will have to embark from Kyrgyz Republic and wait for a new invitation.

Unsigned forms will not be processed. Forms must be signed by the applicant personally.
